General Summary

The Municipal Performance Grant is provided in the form of financial support for municipalities and aims to stimulate them to improve their performance in the field of local democratic governance, municipal management and service delivery.

The Municipal Performance Grant for the fiscal year 2025, based on the performance of 2023, reaches the amount of 7.8 million euros and is co-financed by the Ministry of Local Government Administration (MLGA), the European Union, Switzerland and Sweden.

All municipalities of Kosovo have access to this Grant. However, the beneficiaries of this Grant are the municipalities that meet the minimum conditions. For all municipalities that have met the minimum conditions, the grant amount that each municipality receives is based on the performance achieved in the performance indicators compared to the performance of all other municipalities, as well as other elements of the assessment criteria. For the performance of 2023, 27 indicators have been assessed, while the maximum number of points is 90 points.

Of the 38 evaluated municipalities, 12 municipalities or 32% have met the four minimum conditions and will be the beneficiary municipalities of the municipal performance grant in 2025. The beneficiary municipalities are the municipalities of Dragash, Glogovac, Istog, Junik, Kaçanik, Klina, Lipjan, Mamusha, South Mitrovica, Partesh, Prizren and Suhareka.

Only 34 municipalities have reported for the performance of 2023. However, we have evaluated 38 municipalities, and the overall performance of all municipalities is 47.7% (42.9 points out of a total of 90 possible points), while the average performance of the municipalities that have qualified for the municipal performance grant is 60.2% (54.2 points out of a total of 90 possible points).

The municipality with the highest performance in the 27 performance indicators of 2023 is the Municipality of Glogovac, also a beneficiary municipality. The overall performance score of the Municipality of Glogovac is 82 out of 90 possible points (91.1%). Whereas, the municipality with the lowest performance is the municipality of North Mitrovica with 0%. Of the municipalities benefiting from the Grant, the municipality with the lowest performance is the municipality of Parteš with 4.4% or 4 points out of 90 possible points.

The 12 beneficiary municipalities have achieved an overall performance between 4 (4.4%) and 82 points (91.1%).

The highest amount of the Grant obtained for the fiscal year 2025 is 2,047,132 euros benefited by the Municipality of Prizren, while the lowest is 2,865 euros, benefited by the municipality of Partesh.

The value of the Municipal Performance Grant is between 0.4%-13.4% of the General Grant to the beneficiary municipalities.

1. Introduction- Municipal Performance Evaluation for the 2025 grant

The Ministry of Local Government Administration (MLGA) in partnership with the Swiss Agency for Cooperation and Development (SDC), in 2017 developed and agreed to co-finance the municipal performance grant allocation scheme (hereafter MPG). In 2019, Sweden and Norway and in 2022 the EU through Sweden have decided to join the MPG financing scheme.

The municipal performance grant for 2025 is co-financed by MLGA, EU, Sweden, Switzerland. The total amount available is 7,850,000 euros. In order to monitor the impact of the projects on the citizens, the social audit has been established within the MPG. The amount for the social audit for the year 2025 has been deducted from the total amount of the MPG, therefore the amount that the municipalities will benefit is 7,771,500 euros.

The table below provides details regarding financing sources and the amount of MPG that will be allocated to municipalities in fiscal year 2025.

The municipal performance grant evaluation process for the fiscal year 2025, based on the municipal performance of the year 2023, was carried out in September 2024, in accordance with the minimum conditions and indicators defined in the Performance Grant Rules for the fiscal year 2025.

The Municipal Performance Grant Commission (MPGC) and the Technical Group (TG) are the bodies responsible for evaluating and allocating the municipal performance grant. The complaints commission examines and decides on eventual complaints by municipalities.

To benefit from the Municipal Performance Grant (MPG) of 2025, municipalities must meet four minimum conditions:

Minimum Conditions	
KM1	Municipalities must have reported the data to the MPMS according to the deadline defined in Article 19.2 of the Law on MPMS/MPG;
KM2	Municipalities must have complied with the legal obligations to review municipal acts assessed as illegal by the supervisory authority
KM3	Audit opinion should be at least unmodified with emphasis of matter
KM4	Municipalities must have spent 75% or more of the final budget on capital investments

The Municipal Performance Grant (MPG) for the fiscal year 2025 will be allocated to municipalities in accordance with the points achieved in municipal performance based on indicators in three main areas: (i) democratic governance, (ii) municipal management, and (iii) service delivery. These areas are further divided into ten sub-areas as shown in Table 2. Within these ten sub-areas, 30 performance indicators have been identified, however, for the MPG to be allocated in the fiscal year 2025, based on the municipal performance for the year 2023, 27 indicators will be evaluated with a total number of 90 points.

Performance indicators numbered 3, 16b, 19 and 22 remain frozen for the performance of 2023. Indicator 3 cannot be measured because there is no data reported in the MPMS for this year, while indicator 16b and 19 and 22 are new indicators and will not be measured because the municipalities have not been informed and have not collected data on these indicators. Indicators 27, 28 and 29 are new indicators in MPG, but were indicators in MPMS, so these indicators were measured for the performance of 2023.

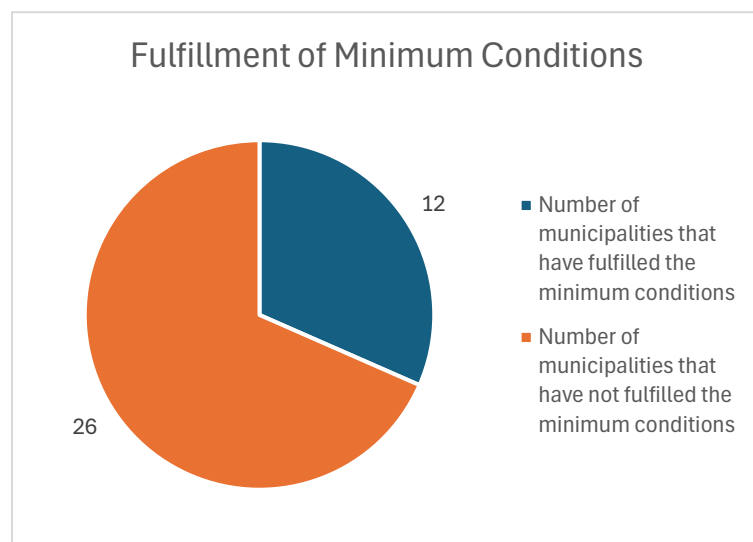
Performance evaluation for the 2025 grant was made for all municipalities of the Republic of Kosovo. Details related to the methodology, process, data collection, are detailed in appendix 5.

2. Municipal Performance Grant for 2025 – Evaluation results

2.1 Results of minimum conditions

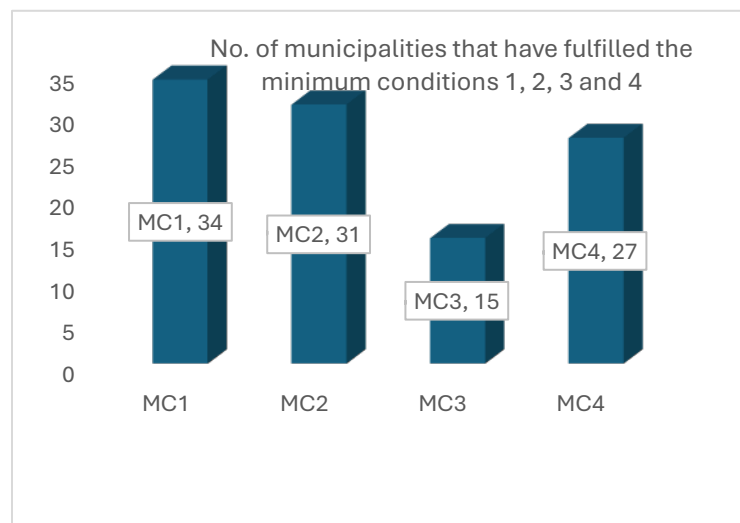
Of the 38 municipalities of the Republic of Kosovo, 12 municipalities or 32% have met the four minimum conditions and will be the beneficiary municipalities of the municipal performance grant in 2025. The beneficiary municipalities are the municipalities of Dragash/Dragaš, Glogovac/Glogovac, Istog/Istok, Junik, Kačanik/Kacanik, Klina, Lipjan/Lipljane, Mamusha, South Mitrovica, Partesh/Parteš, Prizren and Suhareka/Suvareka.

- 34 out of 38 municipalities or 89.4% have met the first minimum condition (municipalities must have reported the data to MPMS according to the established deadline);
- 31 out of 38 municipalities or 81.5% have met the second minimum condition (municipalities must have complied with the legal obligation to review the municipal acts assessed as illegal by the supervisory authority).

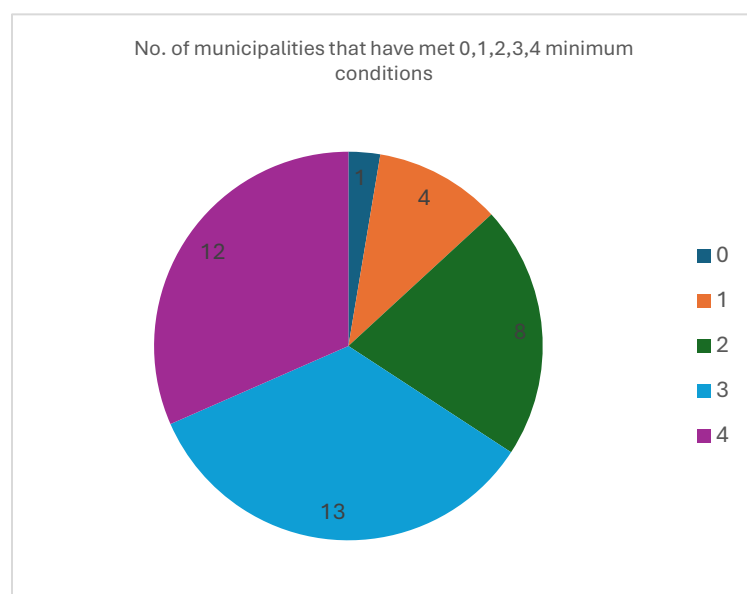
Chart 2 The number of municipalities that have met the MC 1,2,3 and 4



- 15 of the 38 municipalities or 39.4% have met the third minimum condition (the audit opinion must be at least unmodified with an emphasis on the issue).
- 27 out of 38 municipalities or 71.0% have met the fourth minimum condition (Municipalities must have spent 75% or more of the final budget for capital investments).

The summary of the results of the minimum conditions for all municipalities is given in appendix number 1, while appendix number 4 gives a summary of the results for each municipality separately.

Chart 3 The number of municipalities that have not met any MC,



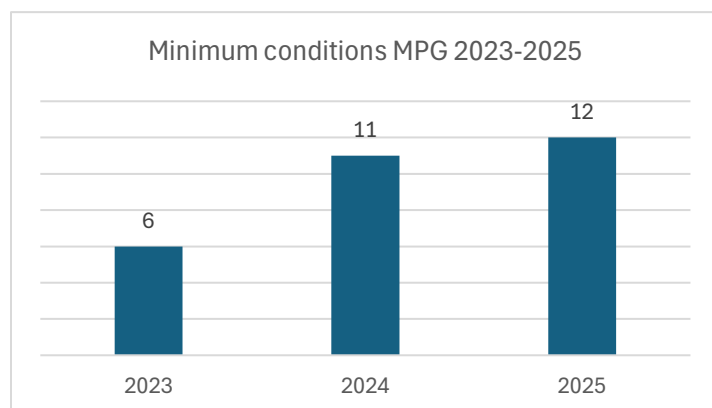
Moreover, as can be seen from the graph of 38 municipalities;

- The 4 minimum conditions have been met by 12 municipalities or 31.5%, which are beneficiaries of MPG for the fiscal year 2025;
- 3 minimum conditions have been met by 13 municipalities or 34.2%. Of them, 11 municipalities have not achieved the minimum condition 3. Whereas, only the municipality of Skenderaj has not managed to meet the minimum condition 2 and the municipality of Shtërpce has not managed to meet only the minimum condition 4.
- 2 minimum conditions have been met by 8 municipalities or 21.0%. Of them, three municipalities have not met the MC2 and MC3, four municipalities have not met MC3 and MC4, one municipality has not met MC2 and MC4;
- 1 minimum condition has been met by 4 municipalities or 10.5%. Of them, one municipality has met only minimum condition 1, while 3 municipalities have only met minimum condition 2.
- No minimum condition has been reached by a municipality or 2.6%.

Chart 4 Municipalities that have reached the minimum conditions GPK 2023-2025

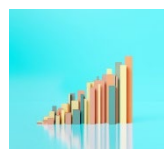


From MPG 2023, we have continuously increased the meeting of the minimum conditions by the municipalities. Of 6 municipalities in MPG 2023 to 11 municipalities in MPG 2024 and 12 municipalities in MPG 2025.

2.2 Results of the Municipal Performance Grant indicators

2.2.1 General results for Municipal Performance Grant indicators

Only 34 municipalities¹ have reported on the performance of 2023 in the Municipal Performance Management System. Despite the fact that 12 municipalities are beneficiaries of the MPG, we have measured the performance of all municipalities. The summarized results are presented below:



Overall performance of the 38 municipalities in the 27 performance indicators for the year 2023, MPG 2025 is 47.7% (42.9 points out of a total of 90 possible points), while the average performance of the 12 municipalities that have qualified for the municipal performance grant is 60.2% (54.2 points out of a total of 90 possible points).



Overall performance of the 38 municipalities increased from last year by 5.5%, from 42.1% in 2022 to 47.6% in 2023.



24 of the 38 municipalities (63.1%) have achieved an overall performance above 50% in the 27 performance indicators. Whereas, among the municipalities benefiting from MPG 2025, 10 out of 12 or 83.3% have achieved above average performance.



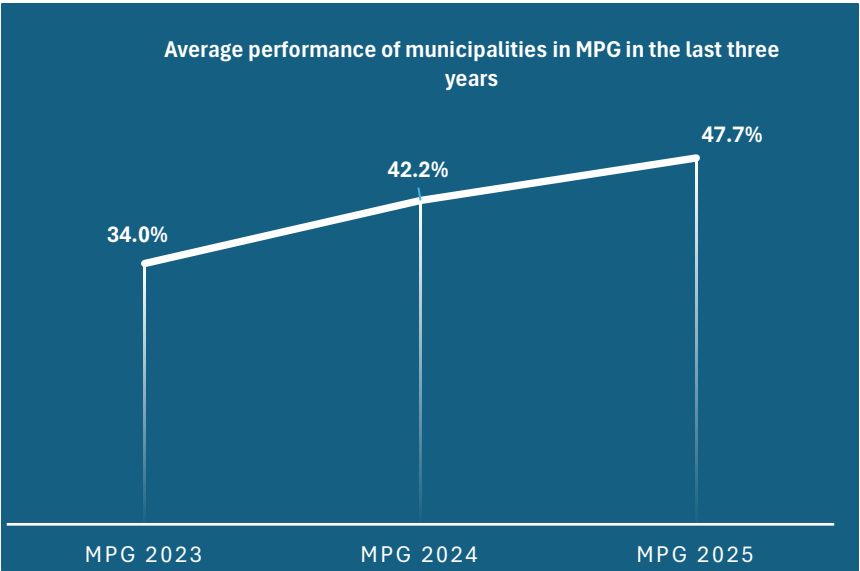
The municipality with the highest performance in the 27 performance indicators of 2023 is the Municipality of Glogovac. The overall result of the performance of this municipality is 82 out of 90 possible points (91.1%). Whereas, the municipality with the lowest performance is the municipality of North Mitrovica with 0%.

Of the municipalities benefiting from the Grant, the municipality with the lowest performance is the municipality of Parteš with 4.4% or 4 points out of 90 possible points.

The 12 beneficiary municipalities have achieved an overall performance between 4 (4.4%) and 82 points (91.1%).

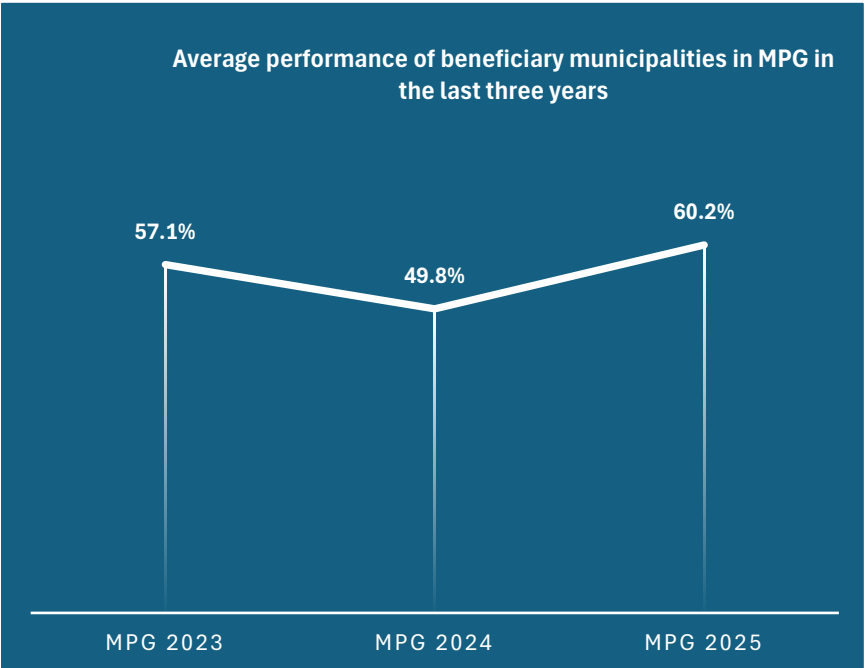
Chart 5 The average performance of all municipalities in the MPG in the last three years



As can be seen from the graphs above, the average performance of all municipalities in the indicators of the Municipal Performance Grant has continuously increased in the last three years. If we compare the average performance with the year 2022, we have an increase of 5.0%, while from the performance of 2021, we have a performance increase of 13.7%. Whereas, from the

municipalities benefiting from the MPG, we have an increase in average performance from 49.8% in the previous year to 60.2% in the current year, or we have an increase of 12.3%.

In addition to the real increase in performance that municipalities may have had, other factors may have influenced the increase in performance in 2023, such as: the reporting of four municipalities more than last year, the revision of the Municipal Performance Management System scheme and Municipal Performance Grant, including clearer guidelines for reporting, ongoing training and consultations before and during the reporting phase, etc.

Below are presented the general results of the performance of each municipality separately.

Chart 7 Overall performance in 27 MPG indicators by municipalities in percentage

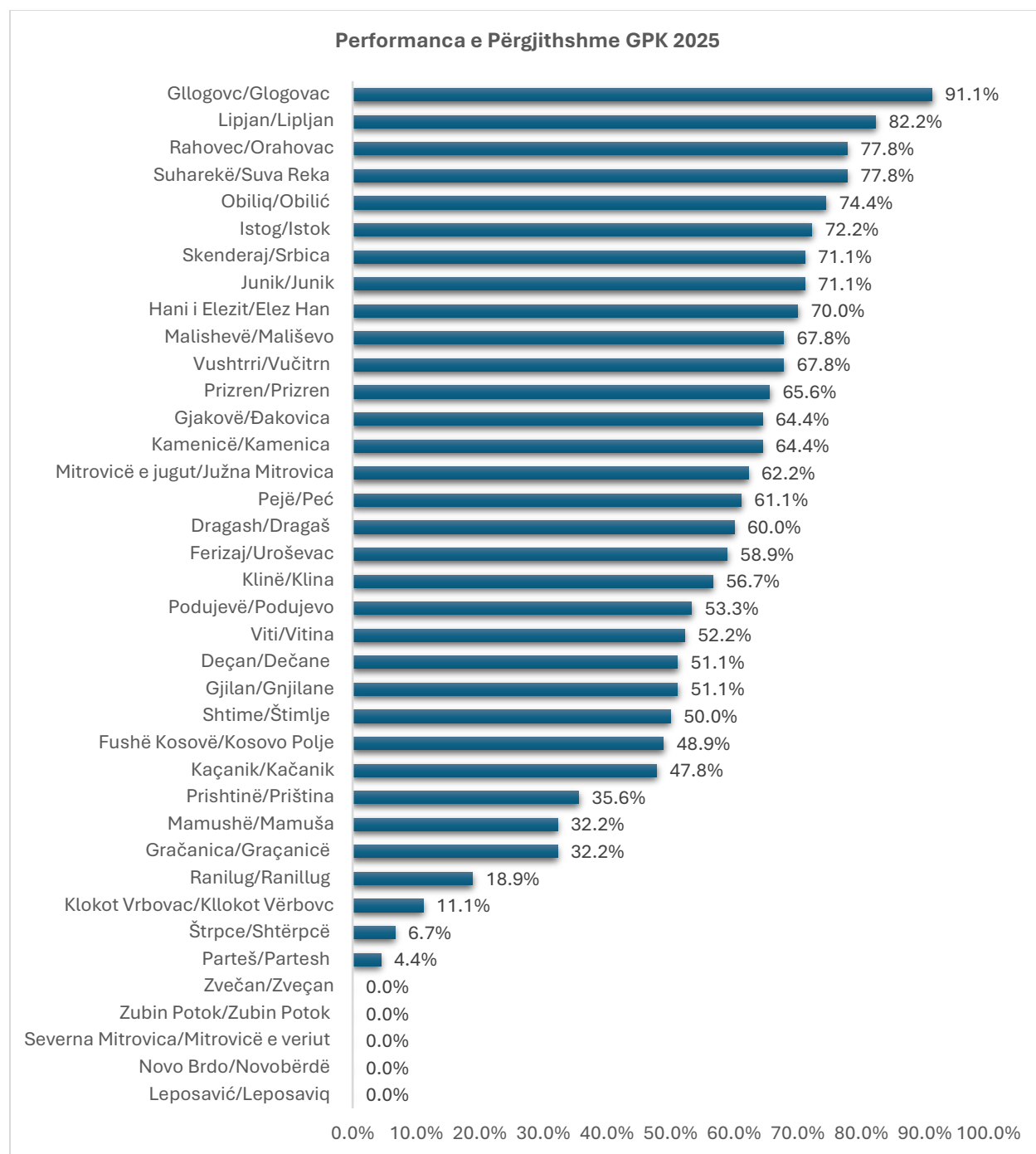
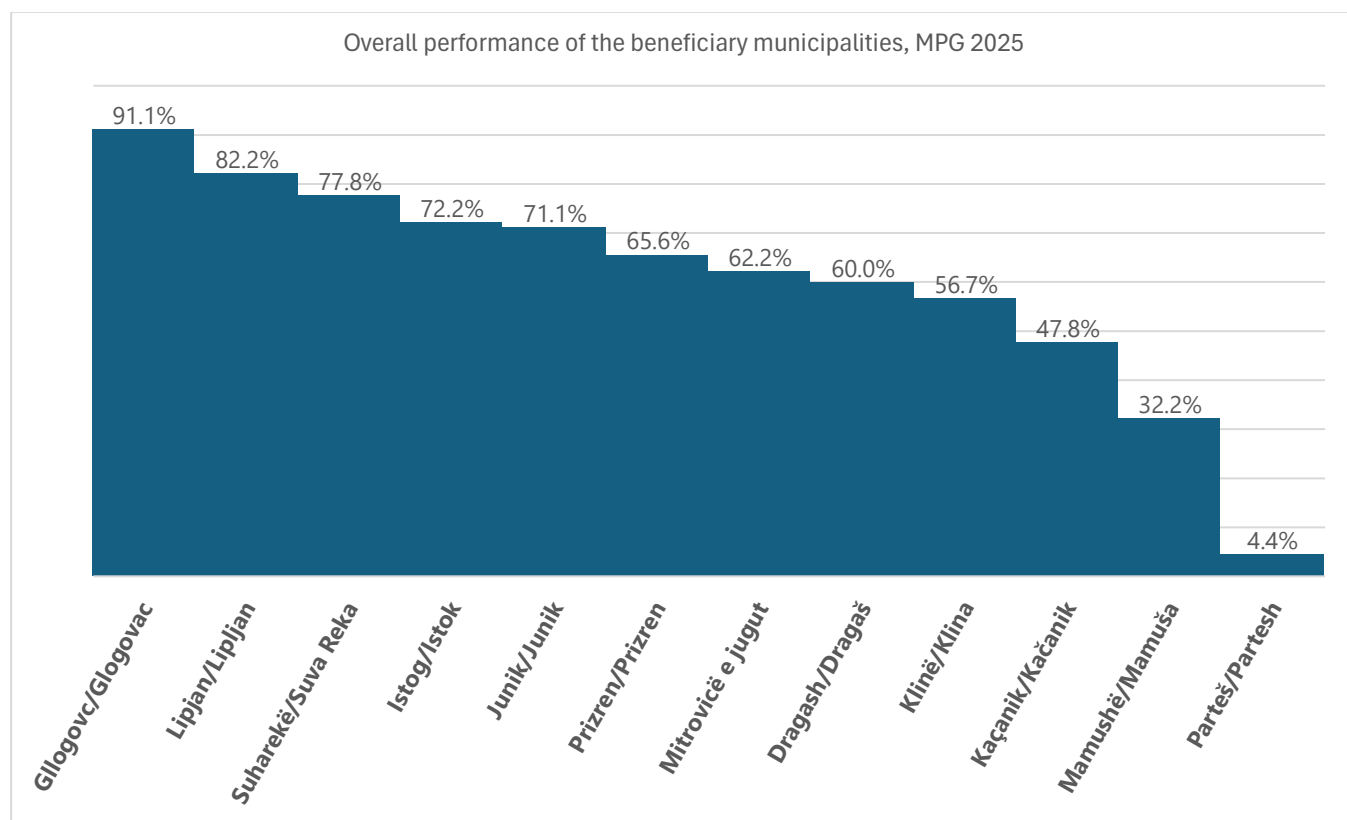


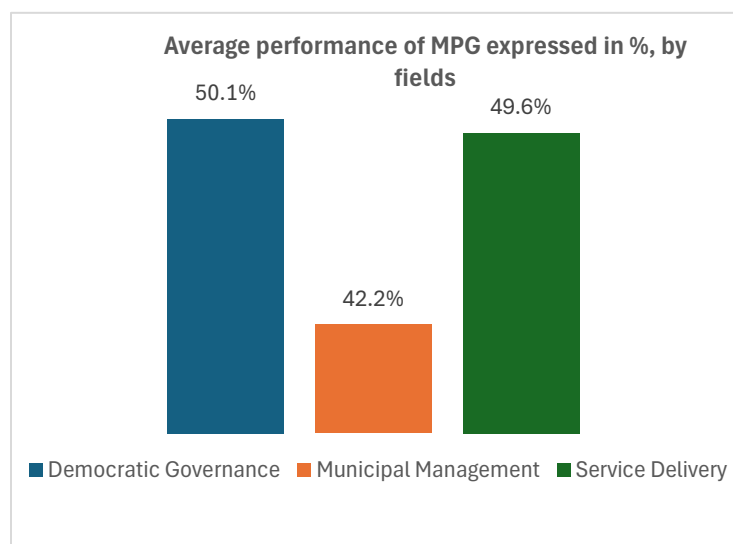
Chart 8 The overall performance of the beneficiary municipalities in 27 MPG indicators in percentage



2.2.2 Results for MPG indicators in fields and sub-fields

The average performance of the 38 municipalities in the field of 'Democratic Governance' is 50.1%, 'Municipal Management' 42.2% and 'Service Delivery' 49.6%.

Chart 9 Average percentage performance by fields

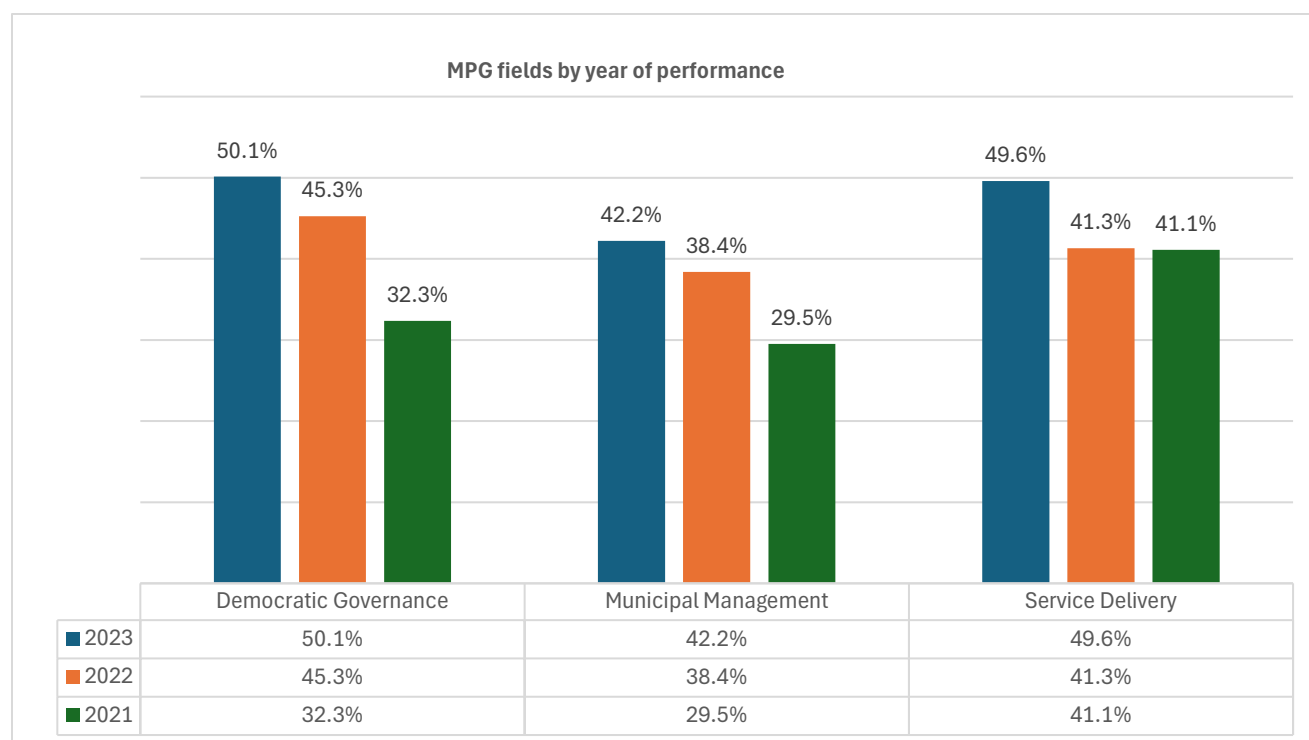


For the performance of 2023, the municipalities had a higher performance in the field of democratic governance.

Also, even among the beneficiary municipalities, the municipalities had a higher performance in the same field.

Whereas, regarding the performance in the fields in the last three years, from the chart below, we can observe that the municipalities have had the greatest growth in the field of service delivery.

The results of performance grant indicators for all municipalities by fields, subfields, indicators are presented in Appendix 2.

2.2.2.1 MPG performance in the field of Democratic Governance

The average performance of the 38 municipalities in the 12 indicators assessed within the topic 'Democratic governance' is 19.0 points out of a total of 38 possible points in this topic (50.1%). The municipalities with the highest performance in this field are: Rahovec/Orahovac and Skenderaj/Srbica municipalities with 36 points (94.7%), while, among the beneficiary municipalities, the Municipality of Glogovc/Glogovac and the Municipality of Lipjan/Lipljane have the highest performance in democratic governance with 35 points each (92.1%).

Whereas, the municipality of North Mitrovica and Partesh/Parteš (beneficiary municipality of MPG 2025), had the lowest performance, with 0 points in this field, followed by Shtërpce/Štrpce with 3 points or 7.8%.

Chart 11 Highest, average and lowest performance in Democratic Governance

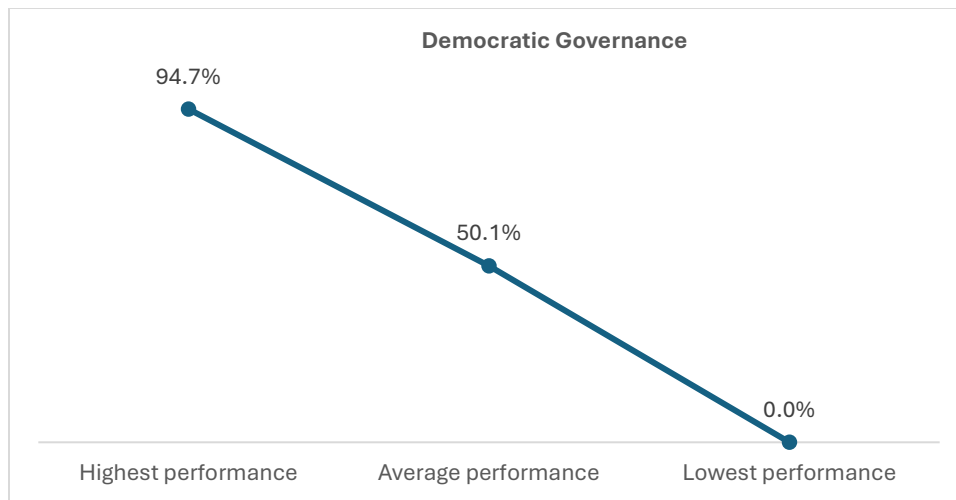
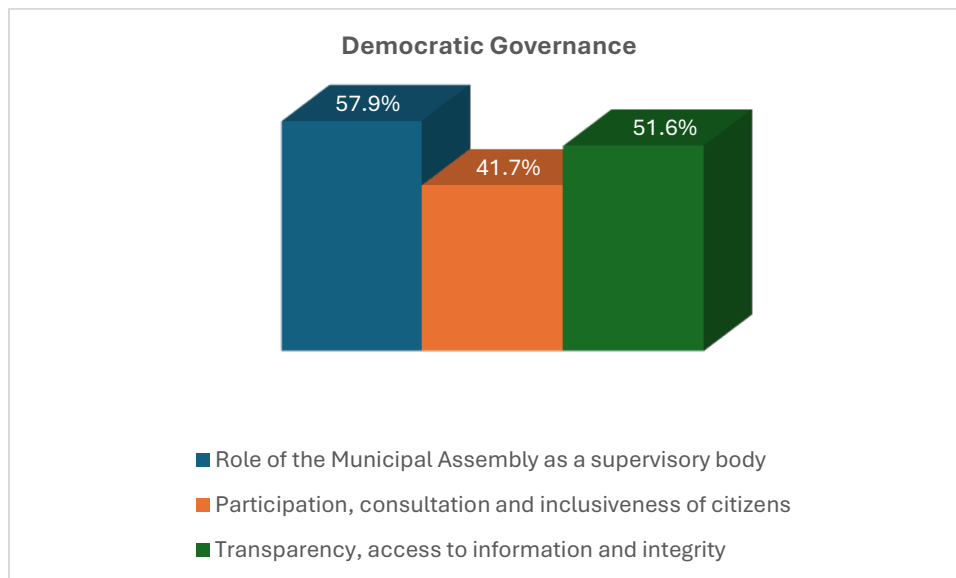


Chart 12 The performance of municipalities in the sub-fields of Democratic Governance



In the sub-field "Role of the Municipal Assembly" as a supervisory body, the overall average performance for 4 evaluated indicators is 5.7 points out of 10 possible points (57.9%).

In the sub-field "Participation, consultation and inclusiveness of citizens", the overall average performance for 3 evaluated indicators is 2.9 points out of 12 possible points (41.7%).

In the sub-field "Transparency, access to information and integrity", the overall average performance for 5 evaluated indicators is 8.2 points out of 16 possible points (51.6%).

Municipalities had the highest performance under the field "Role of the Municipal Assembly".

2.2.2.2 MPG's performance in the field of "Municipal Management"

The average performance of the 38 municipalities in the 7 indicators assessed within the field "Municipal Management" is 10.4 points out of a total of 26 possible points in this field (42.1%). The municipalities with the highest performance in this area are: Glogovac/Glogovac municipality 25 points (96.2%) and Hani Elezit/Elez Han municipality with 22 points or 84.6%.

Whereas, the municipality of North Mitrovica had the lowest performance with 0 points in this field, was, followed by Shtërpec/ Štrpce with 1 point or 3.8%. While, from the beneficiary municipalities, the municipality of Partesh/ Parteš had the lowest performance with 2 points or 7.6%.

Chart 13 The highest, average and lowest performance in Municipal Management

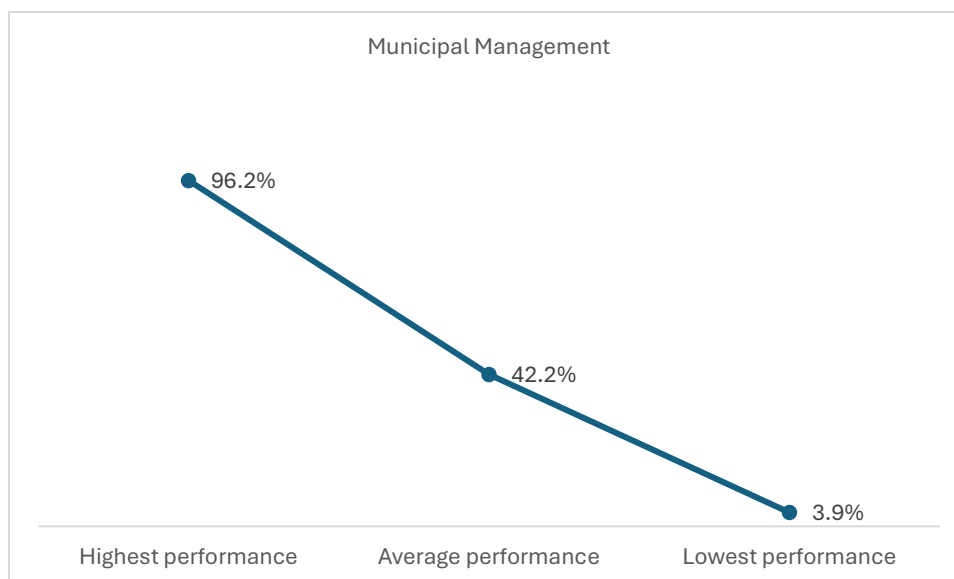
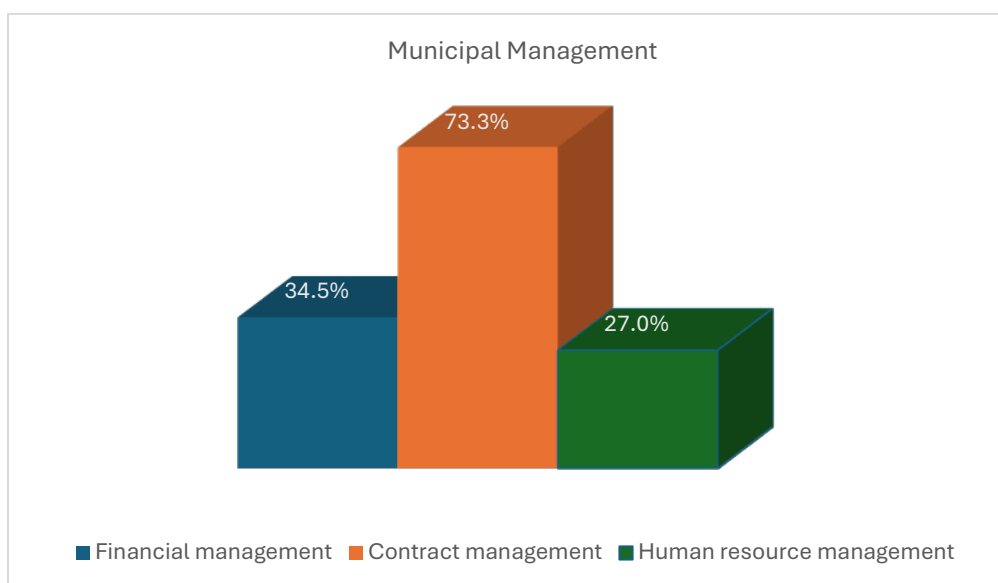


Figure 14 The performance of municipalities in the sub-fields of Municipal Management



In the "Financial Management" sub-field, the overall average performance for 3 evaluated indicators is 3.69 points out of 11 possible points (33.49%).

In the sub-field "Management of the contract" the overall average performance for 2 evaluated indicators is 5.13 points out of 7 possible points (73.31 %).

In the sub-field "Management of human resources", the overall average performance for 2 evaluated indicators is 2.16 points out of 8 possible points (26.97%).

The municipalities had the highest performance under the field "Contract Management".

2.2.2.3 MPG's performance in the field " service delivery"

The average performance of the 38 municipalities in the 8 indicators evaluated within the field "Service delivery " is 12.8 points out of a total of 26 possible points in this field (49.6%). The municipalities with the highest performance in this field are: the municipalities of Lipjan/Lipljane 23 points (88.4%) and the municipalities of Glogovc/Glogovac and Podujeva/Podujevo with 22 points or 84.6%.

Whereas, the municipality of North Mitrovica as well as the municipalities of Graçanicë/ Gračanica, Klllokot/Klokot, Ranillug/Ranilug, Shtërpçë/Štrpce and Partesh/ Parteš (beneficiary municipality) had the lowest performance, with 0 points in this field.).

Chart 15 Highest, average and lowest performance in Service Delivery

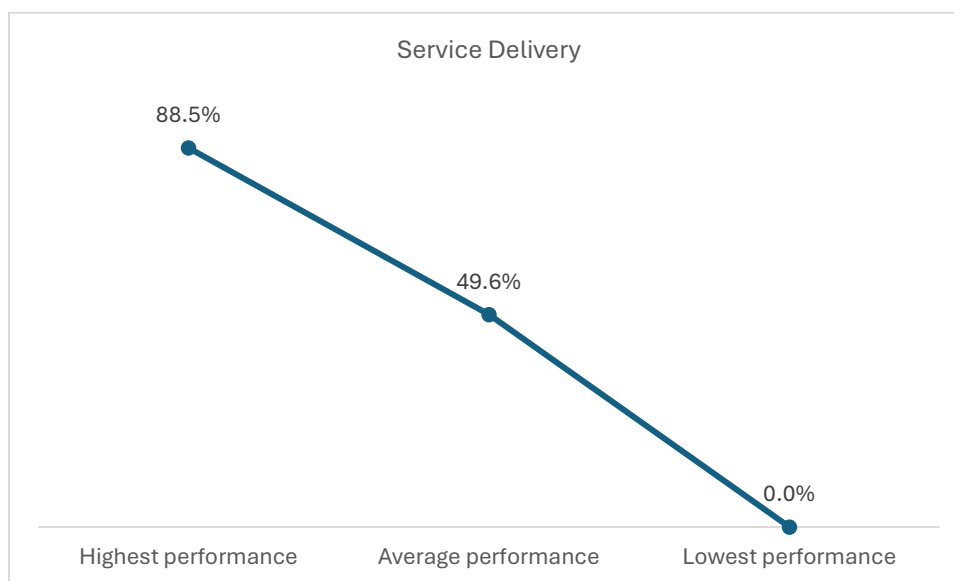
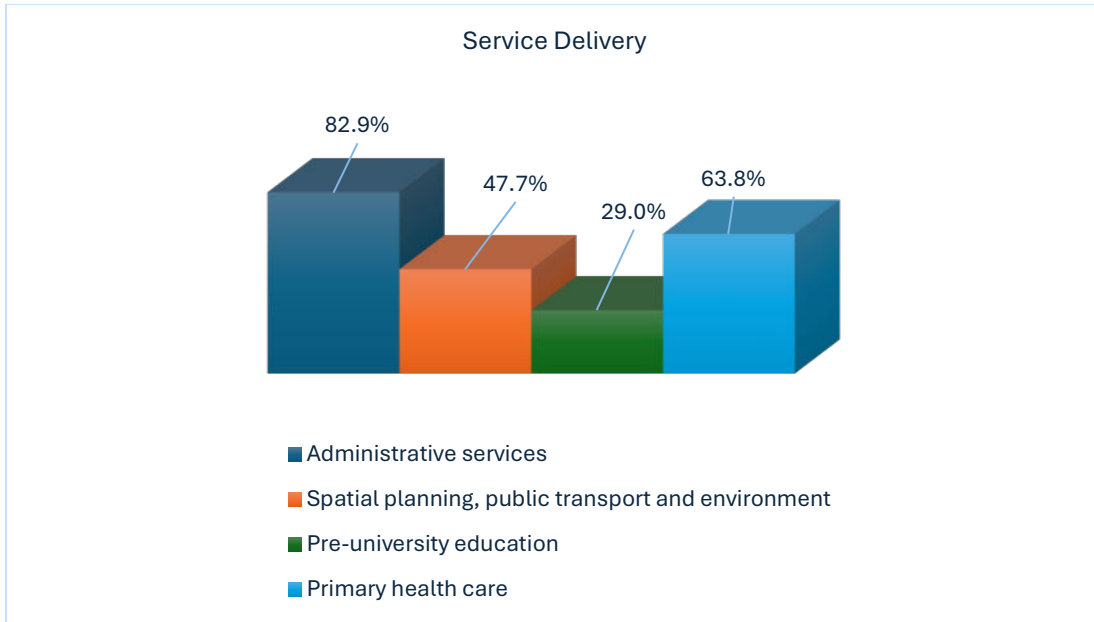


Figure 16 The performance of municipalities in the sub-fields of providing services



In the " Administrative Services " sub-field, the overall average performance for 1 evaluated indicator is 1.6 points out of 2 possible points (82.9%).

In the sub-field "Spatial planning, public transport and environment", the overall average performance for 3 evaluated indicators is 3.8 points out of 8 possible points (47.0%).

In the sub-field "Pre-university education", the overall average performance for 2 evaluated indicators is 2.3 points out of 8 possible points (29.0%).

In the sub-field "Primary health care", the overall average performance for 2 evaluated indicators is 5.11 points out of 8 possible points (63.8%).

The municipalities had the highest performance under the field "Administrative Services".

2.2.3 Results in the MPG indicators

At the level of indicators, the municipalities had the highest performance in the indicator " Requests reviewed for construction permits" with 82.9%, as well as the indicators "Preparation and publication of the list of municipal properties planned to be given for use" and public hearings for MTBF and municipal budget with 73.7 %. Whereas, the indicators with the lowest performance were "Level of compliance with the target ratio of students to teachers" and "Participation of citizens in public consultations" with 15.8%.

Annex 5 Municipal Performance Grant for 2025 - Assessment Methodology

General aspects of the assessment methodology

The 'Rules of the Municipal Performance Grant for the fiscal year 2025', approved by MLGA and the donors involved in the MPG, present the act on the basis of which the assessment for the Municipal Performance Grant for the year 2025 was made. The Rules of the MPG 2025 explain the policies and criteria of the grant as well as provide detailed instructions regarding the performance assessment process.

Period of assessment for the Municipal Performance Grant (Grant Management Cycles)

The period of assessment for the Municipal Performance Grant is divided into 3 main phases:

- Period of assessment - which means the year for which the municipality's performance is assessed. Based on the Rules of MPG 2025, the municipal performance of 2023 is assessed;
- Period of assessment - means the period in which performance assessment is carried out for MPG.
- Period of allocation and use of the grant - means the year in which the grant is made available for use by the municipalities. Based on these Rules, the grant will be available to municipalities in 2025.

Minimum conditions and performance indicators

To qualify for the Municipal Performance Grant for 2025, municipalities must have fulfilled the 4 minimum conditions as follows:

1. Municipalities must have reported the data to MPMS according to the deadline defined in Article 19.2 of the Law on MPMS/MPG²;
2. Municipalities must have complied with the legal obligation to review municipal acts deemed illegal by the supervisory authority³;
3. The auditor's opinion must be at least unmodified, with an emphasis on the matter; and
4. Municipalities must have spent 75% or more of the final budget for capital investments.

Municipalities that have not fulfilled one of the minimum conditions mentioned above will not be able to receive a municipal performance grant, regardless of their points in the performance indicators.

Different indicators have different number of points, depending on the weight and importance attributed to an indicator. Annex 2 of the Rules of the Municipal Performance Grant for FY 2025 contains detailed guidance regarding the allocation of points out of the maximum points. The points are calibrated in such a way so that good and acceptable levels of performance are

² The deadline for the municipalities to report performance data is 45 calendar days from the moment of receipt of the request for reporting from the ministry.

³ 'Review' for the purposes of the MPG is a procedural criterion, which means the obligation of the municipality to review in the Municipal Assembly the acts deemed as illegal in 2022 by the supervisory authority, without presupposing the final content of the reviewed act.

rewarded, but that for each indicator, very few or no points are allocated for sub-optimal performance, which means that the points actually incentivize high performance rather than average performance. This also means that municipalities that perform well in a number of indicators will receive significantly more points than those that show ordinary performance.

For all municipalities that have fulfilled the minimum conditions, the Municipal Performance Grant that each municipality receives is based on its relative points achieved on the 27 performance indicators (its points compared to those of all other municipalities).

Data sources for the assessment of minimum conditions and indicators of the Municipal Performance Grant

Performance assessment data for the 2025 grant come from the following sources: i) The MLGA Municipal Performance Management System Report (SMPK) for 2023; ii) The MLGA report on the functioning of the municipalities of Kosovo for the year 2023 and the Report on the assessment of the legality of the acts of the Assemblies of Municipalities 2023, iii) The annual regularity audit (financial and compliance) reports for each municipality for the fiscal year 2023 published by the National Audit Office.

Assessment process - Institutional arrangements

The Municipal Performance Grant Commission (MPGC) and the Technical Group are the bodies responsible for assessing and allocating the Municipal Performance Grant. The Appeals Commission examines and decides on eventual complaints from municipalities. The Appeals Commission does not review complaints related to the source of data used during the performance assessment due to the fact that this process was exhausted in the first phase of the assessment when the data was approved as final and the parties had the complaint instrument available.

MPGC is the highest decision-making body for the grant. This commission takes the final responsibility for the allocation of the grant. The main function of the MPGC is to ensure that the assessment is done in accordance with the criteria and Rules of the Municipal Performance Grant. MPGC cannot change the assessment results and the grant amounts without the full application of the assessment process in accordance with the Grant Rules.

The Municipal Performance Grant Commission consists of:

- 1 member from MLGA (General Secretary/Chairperson),
- 1 member - public official of the management level of the ministry,
- 1 member - public official from the ministry responsible for finance,
- 1 observer from the European Union in Kosovo,
- 1 observer from Sweden,
- 1 observer from Switzerland, and observers from civil society.

The Technical Group consists of 5 members:

- Four (4) members from the Ministry, employees of the unit responsible for municipal performance or other organizational units;
- One (1) member representing the contributing entities;
- Civil society representatives are also invited to participate in the proceedings of the working group as observers.

The Appeals Commission consists of 3 members:

- 2 representatives from MLGA (one of them the chairperson);
- 1 external representative;
- 2 DEMOS observers.

Members of the Grant Commission or Technical Group cannot also be members of the Appeals Commission in the same assessment period.

Detailed terms of reference for the Technical Group, the Municipal Performance Grant Commission and the Appeals Commission are provided in Annexes 5, 6 and 7 of the Rules of the Municipal Performance Grant for the fiscal year 2025.

Assessment procedures, Preparations

The Technical Group has prepared the Rules of the MPG for the FY 2025. The Rules for FY 2025 have been approved by MLGA and the contributors and then they have been published.

Data collection and assessment

The assessment of the Performance Grant for the fiscal year 2025 was carried out through the Grant module in the Municipal Performance Management Electronic System.

The Technical Group collected the data for the minimum conditions and completed the data of the General Grant for each municipality according to the budget circular 2025/01. This group also carried out quality control of the data transferred to the scorecards and the database.
